IN THE COURT OF HONOURABLE III ADDL CHIEF METROPOLITAN MAGISTRATE AT NAMPALLY, HYDERABAD

Honored Sir,

Facts of the case are that on 24-06-2020 at 1200 hours received a complaint from Sri Vikram Kailas, S/o Ashok Kumar Kailas, aged 38 yrs, Occ : Business, R/o. Amore-U2, Prem Parvat Villas, Road No.14, Banjara Hills, Hyderabad which he stated that one Mr. Prasad V Potluri, who is the developer of the society of Prem Parvath Villa who has handed over the Villa Amore U2 duly executing the Sale Deed vide No.1427/2019 dt.01-03-2019. He is rightful owner of this house and living peacefully in society since then and in continuous uninterrupted possession and enjoyment. They have been living peacefully without any dispute or problem with any one in the neighborhood. While so, in continuation on 23-06-2020 he illegally trespassed with criminal intimidation and threatening. Again on 24-06-2020 at 9.30 am Mr. Prasad V Potluri has forcibly entered with malafide intention and threatened, damaged and terrorized the family members. He warned them with dire consequences and made life threats to them if they do not listen to him, the house was ransacked by the goons who accompanied them. This is a preplanned and pre mediated attack by Mr. Prasad and his accompanying goons. They have intentionally came with a consorted action plan and attacked them and vandalized the premises. On 23-06-2020 they requested the Banjara Hills Police by way of written company to take immediate action. He is attaching all the pictures and videos of this unfortunate act of violence causing severe shock to his family members which includes, his mother, who is a senior citizen and his child who is 6 years old. They apprehend danger to their lives and property. Anything that happens to them, he and his men, agent are responsible. They have life threat from Mr. Prasad V Potluri and his goons. Hence, he requested to take necessary action against Prasad V Potluri as per law
