Dear Sir,

Sub: Reply and Not Response to Show Cause Notice Issued – Regarding.

I am in receipt of your communication and I intend to refer to your letter issued with **"Sub – Show Cause Notice"** dated 23 June 2020. I wish you solicit to address for informational clarity on few of my concerns as reckoning below.

Firstly, the most important correspondence collateral for physical representation of our party which is our letter head, treated as a legal document is itself **lacking legal sanctity** when written as **YSR Congress Party** instead of our actual and exact party name as **Yuva Jana Sramika Rythu Congress Party** as per the Election Commission of India. Please be informed that Anna YSR Congress Party is another political party registered with the Election Commission of India, which is why the objection request for the name YSR Congress Party was refused when applied by our Yuva Jana Sramika Rythu Congress Party dated 6th May 2015. Adding to it, no request or communication for change of the name was ever made at any instance by our party as per the Clause 9 Section 29 A of The Representation of the People Act 1951.

Secondly, I am surprised to see you designating yourself as **National General Secretary** of our party which is a **Registered State Recognised** Party as per Para 6A of the Election Symbols Reservation and Allotment Order 1968 made by Election Commission of India in exercise of the powers conferred by article 324 of the Constitution read with section 29A of the Representation of the People Act, 1951 (43 of 1951) and rules 5 and 10 of the Conduct of Elections Rules, 1961, and all other powers enabling it in this behalf.

Thirdly, have you served this show cause notice in the capacity of National General Secretary? If so **I doubt the authority vested in this chair** with all regards **as per the Party Constitution that was submitted by our party to the Election Commission of India**. It is the bye law of Our Party that we ought to be constituting a Disciplinary committee ever since we intend to call ourselves as a political party and avail of the provisions under 1 of Section 29 A in Part IV A belonging to The Representation of People Act 1951. If that's true and valid kindly enlighten me on whether the same was informed to bring to the notice of the Election Commission under the statute.

Allow me to ask you whether the Election Commission has recognised that committee and notified it? If so, the question arises as to who is its Chairman and members. If there are any? As per the bye laws, before issuing show cause notice, it is unclear as to what procedure was adopted if the disciplinary committee is legally constituted and was the procedure followed, as contemplated under law by such committee if only existing before issuing show cause as on 23.6.2020.

If your answer is affirmative, kindly share with me the Minutes of such meeting as I wish to avail my right to be informed of the proceedings in line with principles of natural justice to promptly respond on your communication.

As from available sources on public domain of Election Commission, Yuvajana Sramika Rythu Congress Party never had any authorised, legally notified nor constitutionally valid recognised Disciplinary Committee to initiate appropriate action against its members on whom a non-cognizance is ever alleged.

I hope and trust you have taken permission from our beloved President Sri Jagan Mohan Reddy garu to use the letter heads with YSR Congress Party printed on it? Since, election commission clearly indicated to us not to use YSR on the letter heads instead instructed us to use it as Yuvajana Sramika Rythu Congress Party only.

As an ardent admirer of our beloved Party Leader and Chief Minister I shall ensure to respect and regard the rules and regulations, policies and procedures, instruction and guidance, ideology and philosophy of Yuvajana Sramika Rythu Congress Party.

However, I earnestly and humbly reserve my right to respond on the contents of your communication served as a Show Cause Notice and wish to inform you that I would stand obligated to answer only upon you establishing that there is a Disciplinary Committee and the procedure stipulated to and notified by Election Commission were strictly adhered to in word and spirit.

If not otherwise, I may have to treat you unauthorised to address this communication and will be forced to take appropriate legal proceedings for misleading one and all.

Furthermore, I request you not to harm the existence of our party. You are causing more harm than anyone else by violating with impunity and militating against the spirit of democracy. With such actions the purpose and objective of the Election Commission will be defeated if you sought to repeat this on specious and unreasonable grounds.

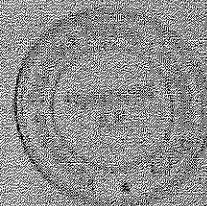
